Spring 2015 Career Development Seminar Content

January

Residential Swimming Pools and the 2012 IRC and ISPSC

This seminar will provide an overview of how various types of pools are constructed, requirements from the IRC and reference standards, how to review for permits, and how to inspect. The presentation will focus on the basics of pool construction, barriers, entrapment protection and standards along with reference to the 2012 IRC and ISPSC, ANSI/APSP Standards and the Virginia Graeme Baker Act. *Milton Gregory Grew, AIA, Grew Design, Inc.*

Identification and Classification of Hazardous Occupancies

This seminar will review the requirements for hazardous materials and “H” Use Groups within Chapter 4 of the Building Code and as referenced by the Fire Safety Code. Content will include material classification, maximum allowable quantities, control areas, construction, egress and protection requirement. *Joseph Versteeg, Fire Code Consultant, Versteeg Associates*

February

The New Fuel Gas Code

The session will be an overview of the 2012 NFPA 54 National Fuel Gas Code which is proposed to be adopted January 1, 2015. Topics will include a breakdown on permits, applying the code, inspection and acceptance of installations. *John Doucette, Office of State Fire Marshal and John Tye, Office of the State Building Inspector, DAS*

Overview of Changes to the IBC (2 of 3)

This seminar is the second in a series of three reviews of the major changes to the 2012 International Building Code (IBC) as compared to the 2003, 2006 and 2009 IBC. Code changes will be identified, as well as the rationale behind the changes. **Please bring the 2012 IBC to class.** *Mark Tebbets, Owner, New England Code Consulting*

March

Fireworks and Special Effects Regulations and Inspections

This seminar will address the Connecticut Fireworks and Special Effects Regulations. Topics covered will include the inspection of permitted fireworks and special effects displays and the investigation of fireworks related

accidents. Also included will be a review of the fireworks statutes, C.G.S. 29-357. *Paul Makuc, Detective, and Joseph Lombardi, Detective, CSP Fire & Explosion Investigation Unit*

Wood Trusses: Theory, Practice and Problems

Prefabricated, metal-plate-connected wood trusses are commonly specified in both residential and low-rise commercial construction. Trusses are very efficient structural assemblies; however, in order to function as intended, they must be properly restrained and braced. This presentation will cover the basics of truss theory and how to read a truss shop drawing. It will describe the importance of temporary and permanent restraint/bracing and illustrate the consequences that can result when proper restraint/bracing is not provided. Unique issues associated with gable end trusses will also be discussed. *Thomas A. DiBlasi, PE, SECB, Principal/President, DiBlasi Associates, P.C.*

April

Fire Resistance Rated Construction

This seminar will review fire resistance rated construction, now titled Fire and Smoke Protection Features, under Chapter 7 of the 2012 International Building Code (IBC). These provisions govern the materials, systems and assemblies used for structural fire resistances, fire-resistance-rated construction. *Douglas Schanne, Training Program Supervisor, OEDM*

HVAC: New Systems and the New Codes

This seminar will provide a review of home and building ventilation requirements based on the 2012 IBC, IMC and IECC. Topics covered will include: HVAC system efficiency requirements, retrofit and new construction applications, solutions contractors will have available to meet requirements, and system performance testing. *Roger Stolting, Territory Sales Representative, EDOS Manufacturers' Reps, Inc.*

May

Emergency Power Systems for Life Safety

This seminar will provide an overview of the installation requirements related to emergency power systems as required by IBC (2012) Chapter 27, 2014 NFPA70, NFPA 110, and NFPA111. The installation specifics pertinent to a Building

Official making inspection of new emergency power systems will be detailed, and the Fire Code/Building Code performance parameters in relation to the life safety systems which are required to continuously maintain electrical power will be explained. Presenters will provide details of the Fire Code Inspector's responsibilities in ensuring that emergency power system maintenance is conducted and properly documented per the State Fire Prevention Code. *Earl Dean, ICC certified Master Code Professional and Fred Mertz, ICC certified Electrical Inspector, IQ Electrical Training.*

Evaluating Fire Protection Systems: Acceptance, Maintenance, Testing and Inspection

From commissioning through system lifetime, strategies for evaluating the function and reliability of fire protection systems by the code official will be presented. Material will be based on 2012 NFPA 72, 96, 13, 14, 20, 25 & CSFSC. June

2012 IECC Compliance Documentation

The seminar will cover the approaches that designers/design professionals could take to provide documentation demon-

strating compliance with the energy code, and will cover the documentation that the building official should request so that compliance with the energy code can be verified, including the documentation required for a building permit or Certificate of Occupancy. The focus will be on the 2012 International Energy Conservation Code (IECC), but the process also applies to the 2009 IECC. Complete and accurate compliance documentation will support Connecticut's goal of achieving 90 percent compliance with the energy code. **Please bring the 2012 IECC to class.** *Fred Wajcs, PE, Energy Code Consultant*

Existing Residential Board and Care—Group Homes and Assisted Living Centers

This seminar will provide a review of the code requirements and decision-making responsibilities for determining occupancy classifications for group homes and assisted living facilities. Residential Board and Care Sections of the 2012 Life Safety Code and amendments, and the State Fire Prevention Code, will be presented. A discussion about the Department of Developmental Services' programs for group homes that are affiliated with their agency will be included. *Timothy Baldwin, Fire Chief, Connecticut Department of Developmental Services, STS Fire Department; Deputy Fire Marshal, Towns of Southbury and Middlebury.*
