#### DIRECTIONS TO LEGISLATIVE OFFICE BUILDING (“LOB”) & STATE CAPITOL:

**FROM I-84 EASTBOUND:** Take Exit 48, “Capitol Avenue.” At light at end of ramp, take a right onto Capitol Avenue. At first light, take a right into driveway for LOB. Stay straight (Capitol Police may be checking all vehicles) and circle around to entrance to LOB garage.

**FROM I-84 WESTBOUND:** Take Exit 48, “Asylum Street.” At light at end of ramp, take right onto Asylum and immediately bear left onto Farmington Ave. At first light take a left onto Broad St. Go under I-84 overpass and take first left into LOB driveway (in front of Armory). Take another left and circle around to entrance to LOB garage. (Capitol Police may be checking all vehicles).

**FROM I-91 NORTHBOUND:** Take Exit 29A, “Capitol Area” (left exit). Follow Whitehead Highway to its end at Pulaski Circle (i.e., a Rotary). Go halfway around rotary and take right onto Elm St. At lights at end of Elm St. take left onto Trinity St. and then at first light take a right onto Capitol Ave. At third light, take a right into driveway for LOB. Stay straight (Capitol Police may be checking all vehicles) going between LOB garage and State Armory and circle around to entrance to LOB garage. **FROM I-91 SOUTHBOUND:** Take Exit 29A and follow directions above or Take I-84 Westbound and follow directions above.

**NOTE: Parking at LOB is free.** LOB garage parking is on first level or basement and should be available prior to 8:15 AM (stay to right as you enter garage). Capitol police may direct you to park on different levels. **NOTE:** Walkway from garage to LOB on level 3 is CLOSED to public. **SECURITY PROCEDURES REQUIRE** us to exit garage on ground floor and walk outside to LOB 1<sup>st</sup> floor main entrance. Go through metal detector and bag screening inside entrance. Capitol Security will confiscate any knives or weapons. In LOB, walk through Atrium and take 1<sup>st</sup> floor underground walkway over to Capitol. **Old Judiciary Rm is on the 3<sup>rd</sup> floor of Capitol (east side).** **ALTERNATE PARKING:** You may park in the Capitol Place parking garage (near Supreme Court) (private bldg. - parking fee/day: ~\$16.00+) or street parking. There’s another secured entrance on west side of Capitol (same screening procedure as in LOB).
